“Stories of Hope and Healing” Art Contest is an activity to raise awareness about mental health in Bexar County. We encourage youth (ages 12 to 17) and adults to participate in this art contest as we recognize the importance of behavioral health and wellness to every person in our community.

Eligibility

The art contest is open to all youth (ages 12 to 17) and adults (18 and over) in Bexar County.

Arts Categories

There are two arts categories: visual arts and literature. Participants may submit one entry in one category. See guidelines below for more details about each arts category.

Participation Requirements

- The entry form must be complete with signatures and all contact information requested. Attach the entry forms to all entries.
- All entries must be the product of the artist/author’s creativity. This art contest is designed to encourage each participant to express themselves.
- Use of copyright material is prohibited. Plagiarized entries will be disqualified. *Plagiarism* is defined as taking and using another person’s ideas, writings, or inventions as one’s own.

How to Submit

All entries must be submitted by September 30, 2017. Complete, sign, and attach one entry form to the submitted piece of artwork. Finalist will be notified approximately one week prior to the start of the conference. **All entries become property of the Bexar County Behavioral Health and Wellness Conference and will not be returned.**

All entries will be on display at the 17th Annual Bexar County Behavioral Health and Wellness Conference from October 20-21, 2017 at the Norris Conference Center (618 NW Loop 410, SAT 78216).

Visual Arts Guidelines

Visual Arts include many art forms that are visual in nature. The artist (youth or adult submitting an entry) is a person who captures their own thoughts and ideas to create a visual piece of art.

Accepted forms of visual art include: original paint, drawing, painting, collage, computer-generated, or photography. Visual Arts entries must be 2D.

Submission Requirements:

- Each entry must be the original work of the artist.
 - Artwork must not exceed 24x30 inches, including matting.
 - Artwork must be flat and not more than 1 inch thick. Framed artwork is not accepted.
 - Label back of entry with artist name, age, grade (if applicable), and title.
 - Attach the completed entry forms to the back of the artwork.

Literature Guidelines

Literature is the art of writing. The author (youth or adult submitting an entry) is a person who expresses their own thoughts and ideas through the use of words.

Accepted forms of literature include: poetry, reflective essay, or short story. Literature may be fiction or non-fiction. Literature entries may be hand-written legibly or typed.

Submission Requirements:

- Each entry must be the original work of the author.
- Entry must not be more than 2,000 words.
- Hand-written and typed entries are accepted on 8.5x11 paper (one sided only).
- Label the back of the entry with the author's name, age, grade (if applicable), and title of literature.
- Attach the completed entry forms to the entry.
